Condition and Use of Fields. Charlie Fafard and JC Crouch met with Randall Kramer from Parks & Rec. League players do a lot of work preparing fields for play, as on April 29th, when they got Baptiste Field ready for all but the first game. Wes Kaui and others from the *Gents* got the inundated field ready, in the absence of anyone from Parks & Rec. Charlie and JC are also working to get Hanamaulu (Peter Reyno, Sr. Field) better cared for, and Puhi Field repaired. There are also issues with dugouts and even fields being locked, and outfield grass not mowed.

P&R does not want vehicles at Hanamaulu Field or Wailua Houselots. They will allow vehicles to drop off equipment at Wailua Houselots Field before games, but the vehicles can't stay. At Hanamaulu, the school parking lot will be accessible for parking for games.

Randall assured JC that Puhi Field would be fixed, but no firm date given.
Isenberg Field is heavily used. P&R wants to line the field on Thursday for Friday games., but teams are scheduled to practice later, and there are also games on Thursday
