# KAUAI SENIOR CITIZEN SOFTBALL ASSOCIATION <br> BOARD OF DIRECTORS MEETING <br> November 3, 2021 <br> Hanamaulu Pavilion 

The meeting was called to order at 6:30 p.m. by J.C. Crouch in the absence of President Joe Bertucci and with League Coordinator Mike Curtis running late (Mike took over after his arrival). A quorum was present as determined by roll call, including three new teams Kauai Sons, Imi'Ola and Bushwackas, for a total of 15 teams (Rebels and Ohana have dissolved). Absent: Solid Steel.

## Approval of Agenda

The Agenda, distributed by email prior to the meeting, was approved by motion, second and vote.

## Approval of Minutes of Meeting of September 1, 2021

The Minutes of the meeting of September 1, 2021 (there was no meeting in October, 2021), distributed by email before the meeting, were approved by motion, second and vote.

## Treasurer's Report

Stephen Fujii's Treasurer's Report, distributed by email before the meeting, showing all income and disbursements from January 1, 2021, through October 31, 2021, was approved upon motion, second and vote. The Ending Balance as of October 31, 2021, was $\$ 10,711.77$. This amount includes only 2 teams' 2022 season fees. Kauai County's $\$ 5,000$ grant has not been received.

Treasurer Fujii also distributed a proposed 2022 Season Budget, with a total proposed expenditure of $\$ 9,575$, and a projected balance at the end of the season of $\$ 4,636$ (assuming payment of all team fees, but not including $\$ 5,000$ grant due from County).

The Report and Budget were approved by motion, second and vote.

## League Coordinator Report: Mike Curtis

Prior to the meeting, Mike distributed by email: a 2022 Schedule showing the fields for each Saturday's games, with a season starting January 8, 2022, and ending in late July; a page showing the contact information for team coaches, team practice fields and times, and contact information for league officers; and, a blank roster (Team Registration and liability waiver sheet).

Bushwackas will take over Ohana schedule at Eleele for practice.
Imi'Ola will practice at Puhi.
Kauai Sons will practice at ??.
2022 schedule will be two full rounds for 15 teams, 28 games through July 23, 2022 (one extra Saturday). Win/Loss record on two complete rounds will determine final standings; usual rules for ties (head to head, then point differential).

County's $\$ 5,000$ grant for the 2021 Tournament is "in the process". $\$ 250$ team entry fee due by December First.
Rosters are due on January 5, 2022, by latest!
The League has balls ( $8-12$ dozen) left over from the Tournament, so the 2022 budget figure for balls can be lowered. There are no balls available for teams: buy from SportStan.

2022 schedule is a "work in progress" for the County. Parks \& Rec has to look at potential conflicts; there are more girls' softball teams this year, for example.

The host team should be the home team, playing the first game.
It is not clear if there will be opening day ceremonies. Probably not, due to Covid.
John Patt: 70's Division (Discussion prior to meeting)
John passed out a summary description of a proposed age 70 and up division (up to 3 players 68 or 69 ; unlimited females over 60 ). The division would use small ball ( 12 " softball) and 65 ' bases, with 11 fielders. The division needs four teams to start. Playing in this division would not preclude playing in the regular league. John said the current thinking is that games would be played on Saturdays, following the regular division's games. A 70's division apparently was previously authorized.

## League President Report: Joe Bertucci

Jeff Kimoto was nominated for the office of President by Islanders. Seconded. Jeff is invited to the December meeting to make a presentation; and any other person interested in the position may also come and present.

All other offices are filled.

## OLD BUSINESS

Following discussion at the prior meeting and language drafted to reflect the expressed view on two potential changes to Association governing documents:

## Players Changing Teams

A replacement Playing Rule 13 was adopted after motion, second and vote:
Team Players: A player is committed to a team for that season upon signing the roster for the team and playing in a game. If a player on the roster hasn't played in any game, the player may change teams upon proper signing of the other team's roster. A player on a team's roster can only otherwise switch teams if the player's original team is dissolved.

## Emergency Meetings

A new Section 2 was added to Article XI of the Constitution (succeeding section of Article XI to be renumbered) after motion, second and vote:

A majority of the serving officers may call a Special Meeting of the KSCSA League Board to consider any issue which requires action before the next regular meeting. The Notice of Meeting shall include a description of the issue to be considered. At the meeting only the issue specified in the notice and related topics may be considered; any other issue is considered tabled until the next regular meeting. Nothing in this section affects other provisions which require advance notice for amendments to the Constitution or By-Laws.
