UNFINISHED BUSINESS

2025 Season:

JC said P&R was originally against the 70s division's using Puhi Field, but now it is approved for 70s play. "Permit approved" for Thursday play.

Puhi Field can use more work. Tom Christie and Mark Kuehler have done great work with the holes, but there are still pukas to be filled and other work. 65' pins are in, but those at 2nd and 3rd must be raised. JC says Kurt is the main guy they work with, so schedule the work party with him (best: first thing in the morning).

John had distributed prior to the meeting a format for the proposed 70s Tournament. It would be a one day tournament, on Friday, after the end of the regular State Tournament. 8 teams; single elimination, but a loser's round, so all teams are guaranteed two games, with three games for the teams in the championship/ consolation games. Tournament to end by early afternoon, so players can fly out Friday night. Games might start as early as 8:00 a.m.

John thinks that four fields will be necessary. Koloa has two fields, and is the only locale with two fields approved for 65' play. Kaumakani and Puhi have only one field. Using fields at different locations will require travel between the fields.

A suggestion was made to play at one locale, with two fields, but keep the games going quickly and schedule 1-1/2 hours per game. Another suggestion was to use 14' balls.

Dom delegated to John Patt authority to contact other counties/teams to gauge interest. Further discussion was otherwise tabled until the Board meeting in October.
